NOTES FORMING PART OF ACCOUNTS FOR THE PERIOD ENDED 31ST MARCH, 2017

The Telangana Cricket Association (the "Association") is registered under Societies Registration Act, 2001 vide Registration No. 967 of 2015 w.e.f 01.08.201.It is mainly involved in promoting and developing cricket in rural areas of Telangana State.

I. SIGNIFICANT ACCOUNTING POLICIES

1. GENERAL

The financial statement of the Association have been prepared and presented under the historical cost convention following the actual concept of accounting in accordance with the generally accepted accounting principles in India. Expenses and Income to the extent considered payable andreceivable, respectively, are accounted for an accrual basis, expect those with significant accounting uncertainties.

The preparation of financial statement in conformity with Indian GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent liabilities on the date of the financial statement. The recognition, measurement, classification or disclosure of an item or information in the financial statements is made relying on these estimates. Any revision to accounting estimates is recognized prospectively.

2. FIXED ASSETS

Fixed assets are carried at cost of acquisition less accumulated depreciation/amortization and impairment loss, if any.

Subsequent expenditure related to an to an item of tangible asset are added to its book value only

3. INVENTORIES

Inventories are valued at the lower of Cost or Net Realizable Value. Cost is computed by using "weighted average" method.

4. REVENUE RECOGNITION

Membership fee / subscription is accounted as "Income" on accrual basis and amounts received in advance are shown under the current liabilities and recognized in the year to which it relate.

Interest income is recognized using time-proportion method

5. DEPRECIATION

Depreciation on Fixed Assets has been provided at the rates and in the manner as prescribed u/s 32 of the Income Tax Act, 1961.

6. TAXATION

Income tax expenses comprise current tax (i.e., amount of tax for the year determined in accordance with income tax law) and deferred tax charges or credit (Reflecting the tax effects of timing differences between accounting income and taxable income of the year).

The deferred tax charge or credit and the corresponding deferred tax liabilities or assets are recognized using the tax rates have been enacted or substantively enacted by the balance sheet date. Deferred tax on assets are recognized and carried forward only if there is a virtual / reasonable certainty of realization of such assets near future are reviewed for their appropriateness of their respective carrying value at each balance sheet date.

7. IMPAIRMENT OF ASSETS

In accordance with AS 28 on 'Impairment of Assets' where there is an indication of impairment of association's assets, the carrying amounts of such assets are reviewed at each balance sheet date to determine whether there is any impairment. The recoverable amount of such assets is estimated as the higher of its net selling price and its value in use. An impairment loss is

Contingent liabilities, if any are disclosed in the notes to accounts and are determined based on the Association's perception that these liabilities are not likely to materialize. Contingent assets are not recognized or disclosed in the financial statements
